This is to advise of the following Direction of Her Honour Case Management Judge Aylen dated July 12, 2021:

“Further to the Court’s Order dated April 8, 2021, enclosed is an Order issued in T-130-21 striking the Statement of Claim, without leave to amend. Accordingly, T-130-21 has now been finally determined.

For the benefit of the parties, the Court is also providing the parties with a copy of a recent decision of the Chief Justice of the Federal Court in Spencer v. Canada (Health), 2021 FC 621, in which the Court held that the COVID-19 hotel quarantine requirements do not infringe section 6, 7, 8, 9, 10, 11 or 12 of the Charter.”
