**ORDER**

[1] On or about May 16, 2023, I issued the following direction in these proceedings:

These actions have been stayed pending the final determination of the proceedings in T-130-21 (the proceeding commenced by John Turmel).

The statement of claim in T-130-21 was struck, without leave to amend, by prothonotary Ayles (as she then was, as that office was then titled) on July 12, 2021. Her decision was upheld on appeal (*Turmel v Canada*, 2021 FC 1095). A further appeal to the Court of Appeal was dismissed (*Turmel v Canada*, 2022 FCA 166). Mr Turmel's application for leave to appeal to the Supreme Court of Canada was dismissed (*John Turmel v. His Majesty the King*, 2023 CanLII 39581 (SCC)).

The decision in T-130-21 to strike the statement of claim is therefore final.

Any party that wishes to requisition a case management conference to establish a schedule for a motion to determine whether their action should continue must do so by June 15, 2023. If no request for a case management conference is made by that date, the action will be dismissed on the same grounds as the proceeding in T-130-21, and the parties will be invited to make submissions as to costs.

[2] The deadline to requisition a case management conference has passed. The plaintiff in T-138-21 and each of the Court files listed in Annex A have not indicated an intention to proceed with their claims, and no notices of discontinuance have been filed.

[3] The statements of claim in all these actions will be struck, without leave to amend, on the same grounds as the proceeding in T-130-21.

**THIS COURT ORDERS that:**

1. The statements of claim in Court file T-138-21, and each of the Court files listed in Annex A to this order, are struck, without leave to amend.
2. His Majesty the King, the defendant in T-138-21 and each of the Court files listed in Annex A to this order, shall serve and file submissions as to costs within 10 days of the date of this order, not to exceed 5 pages. Any responding submissions as to costs from the plaintiffs in T-138-21 and each of the Court files listed in Annex A to this order shall be served and filed within 20 days of the date of this order, not to exceed 5 pages.

3. A copy of this order shall be placed in Court file T-138-21 and each of the Court files listed in Annex A.
